CONDITIONS

WEDDING TERMS & CONDITIONS

Payments:

Booking confirmation - We will hold your selected date for 2 weeks.

A deposit of 25% of the total food account is required to confirm your event. The deposit must be accompanied by a signed and initialed copy of our wedding agreement.

Two further installments of 25% thereafter: dates to be arranged

Final payment is due 2 weeks prior to your event with final guest numbers & seating plans. NB: If guest numbers are under the required amount, payment of minimum numbers will still apply.

Payments can be made by direct deposit, cash or cheque

Cancellation:

Within 6 months of the event all deposits are refunded in full. Thereafter all deposits will be forfeited or may be transferred to another date (subject to availability). This new booking may be subject to menu and price changes

Menu Selection:

Menu selection must be confirmed 30 days prior to the event

Seating:

Floor plans will be done in consultation with wedding party and are subject to change according to numbers and weather conditions

Music:

Please ask before arranging bands or DJ's to make sure there is sufficient room allocated. Noise levels will be monitored by Acqua Vista staff. This is for the enjoyment of guests and in respect to the residential surrounds

Liability:

Any damage sustained to our premises or property by guests or contractors during your function is your responsibility. We do not accept any responsibility for damage or loss of you or your guests' property left during the course of, or after the function.

We reserve the right to exclude or remove any undesirable persons from the premises without liability.

Non Smoking Policy: Please note this includes our deck area

Alcohol Consumption:

Due to our responsible service of alcohol requirements we are legally bound to refuse service to any guest we deem to be drunk, disorderly or under the age of eighteen.

Any hint of violent behaviour and the guest will be asked to leave immediately.

Parking

There is ample parking in the public car park at the restaurant and the area is well serviced by taxis.

Noise Management: Guests are at all times to follow the direction of management in relation to the noise and music levels at functions and agree that they and their guests will leave the venue in an orderly and quiet manner without disturbing our neighbours.

Prohibition on food & beverage: Food and Beverage may not be brought into, or removed from the venue without the prior consent of the Management

Beverages: The Restaurant is fully licensed there is no BYO.

Validity: Prices quoted are valid for fourteen (14) days from date of quotation. Thereafter prices may be subject to change.

Damages: Organisers are financially responsible for any damages or loss sustained to the premises during the course of a function.

Vegetarian/special diet: Please notify us prior to your booking if there are any special dietary requirements, so our chef is able to cater to your guests needs whenever possible.

Prices:

Prices are based on current costs and are subject to change without notification. All prices are inclusive of GST.

Confetti & Table Scatters – Metallic or similar:

Please abstain. Rose petals are permitted outside only.

Decorations:

The only table decorations included in our packages are white tablecloths and napkins and LED candle votives. You are welcome to provide your own flowers, name tags, candles, seating plans etc. The placement of these on the day is the responsibility of the person accepting these terms and conditions unless other arrangements are made and confirmed in writing.

Please note that any candles MUST be enclosed in a votive or similar – i.e. no naked flames
